Motion by Member Costello, second by Member Vesely to approve the minutes of the August 19, 2008, meeting. All aye; motion carried.

Prior to the meeting Member Costello reviewed all the bank statements and Treasurer's Reports. Motion by Member Costello, second by Member Vesely to accept the Treasurer's Report. All aye; motion carried.

 - c) Motion by Member Vesely, second by Member Costello to approve installation of a Magnegrip connection for our exhaust capture system. This will be just the engine 3 connection at a cost of \$600. This will be a trial to see if the system will work for us. All aye; motion carried.
 - d) Motion by Member Costello, second by Member Vesely to have tint condition install film on 10 windows at station #1 at a cost of \$1425. All aye; motion carried.

- a. Asst. Chief Kutz was involved in a car/deer MVA. Quotes have been submitted to the insurance company.
