- 1. Back parking lot:
 - The binder coat will go on tomorrow. Estimate of \$6,000 to re-mill and pave the upper part of the driveways (paved last year) and then seal coat and restripe will cost \$1975. Discussion followed. Consensus was that we will wait and see what it looks like.
 - The lighting is almost complete. The front lights over the bays will now come on automatically with the other lights.
 - The awnings are on order and should be in soon.

She has recently left Maine Fire and went to Port Crane Fire Co., so we need to change our mutual aid agreement covering her. Chief noted that there are 3 or 4 other Port Crane members who are interested in being on our rope rescue team. Once he has the names we can contact our attorney about this.

d) Since auxiliary members became part of the fire company still a lot of confusion about how new members are handled. Chief wrote up a procedure that explains the procedure for new auxiliary members. Motion by Member Bush, second by Member Battaglini to approve the SOG for auxiliary membership. All aye; motion carried.

- 9. Motion by Member Bush, second by Member Battaglini to approve Shawn Beach, Andrea Fink, Devin Lasher and Kurt Volberg as new members of the fire company. All aye; motion carried.
- 10. Motion by Member Bush, second by Member Battaglini to pay bill to S & M Deli for \$70.96 upon receipt. This was for food for the standby crews for the incident on Luther Street. All aye; motion carried.
- 11. Motion by Member Bush, second by Member Battaglini to receive and file minutes of the auxiliary meeting of 9/24/13. All aye; motion carried.
- 12. Discussion of auxiliary access to credit cards. They need to have access so they can purchase food and refreshments when we have fires or other incidents where they are on the scene for long periods of time. Discussion of possibly a safe that could be accessed with our keyless entry fobs so we would always know who accessed the box. We would keep a Weis and Wegman's card in the safe which the auxiliary could use. All receipts would be turned in immediately. We will contact Sentry Alarms to see if they have an add-on to our system that would work with a small safe.

No one present had any comments on the 2014 budget so the budget hearing was closed at 6:25 pm.

This complies with the New York tax cap requirements. All aye; motion carried.
