Meeting called to order at 11:02 am by Treasurer Tony Fiacco who acted as Chairman.

- 1. Election of Fire District Officers:

- 5. Motion by Member Anderson, second by Member Battaglini to authorize the Treasurer to invest funds per the Endwell Fire District investment policy. All aye; motion carried.
- 6. Motion by Member Anderson, second by Member Bush to authorize Treasurer to pay utilities, payroll, debt service, credit cards and special check request as due. All aye; motion carried.
- 7. Motion by Member Bush, second by Member Battaglini to designate the Press & Sun Bulletin as the official newspaper of the Fire District. All aye; motion carried.

- 11. The Treasurer presented all records for review. Motion by Member Anderson, second by Member Battaglini to accept the records. All aye; motion carried. The Treasurer is still finalizing reports for 2017. As soon as that is completed all records will then go to Jerome Bignoli for the annual report to be completed for the state and then to Mondorf & Fenwick for the mandated state audit.
- 12. Motion by Member Battaglini, second by Member Anderson to appoint Oliver Blaise III of Coughlin & Gerhart as our attorney for 2018. Member Pandich will reach out to Mark Butler to see why he has decided to close our file with his office. All aye; motion carried.
- 13. Motion by Member Bush, second by member Anderson to approve payment of bills, vouchers #12-078 to 12-098 and 12-100 to 12-109 including Payroll totaling \$11,577.25. All aye; motion carried.

- 14. Motion by Member Anderson, second by Member Bush to approve company events for 2018. All aye; motion carried. Parades will be approved when dates are received.
- 15. Member Bush open the discussion up again about purchasing the AT&T Signal Booster for Station 1. There are members in the department that cannot get cell service when in certain parts of the building. There was some discussion on the need to purchase a \$695 booster. Motion by Member Bush, second by Member Battaglini to purchase the AT&T Signal Booster from Amazon for Station 1. All aye; motion carried.
- 16. Petcosky & Sons Plumbing and Heating submitted their proposal for the ductless units. Their cost for the project would be \$17,061.00. We are currently still waiting the requote from Evans Plumbing.
- 17. Motion by Member Anderson, second Member Bush to have Picket Painting complete the interior painting at Station 1 for the amount of \$8,800.
- 18. Member Anderson reached out to Denis Nixon at AC Spear Electric to see if they could write the specs for the generator so that the Board could a bid out for the generator replacement. Denis had to check with the owner first after he returned from Vacation and he would let Member Anderson know. Member Anderson will follow up again with AC Spear Electric.
- 19. We received donations from Holly Jordan (\$100.00) and Dana Gray and John Nicolich (\$100.00) in memory if John Mehal. Motion by Member Bush, second by Member Battaglini to place the donations in the account for a new message board sign (D40). All aye; motion carried.
- 20. Member Pandich stated that he has been in contact with Oliver Blaise II of Coughlin & Gerhart about the zoning with the Town of Union. Oliver has reached out to Daria Golazeski with the Town of Union Permits / Code Enforcement / Zoning department to work on getting the requested variance from the Town for the new sign. Member Pandich will have Oliver write a letter to the Town Board stating what our usage would be for the sign.
- 21. Rob Brady mention that John Ruck will be will be coming up on 50 years of service to the department and he would like to have the District pay for small bell to present to him at either the Inspection Dinner or the Dinner Dance. Motion by Member Battaglini, second by Member Anderson to purchase the small bronze fire bell. All aye; motion carried.
- 22. Rob Brady and Tom Palazzo will be working on getting the plaques put up on the trucks.
