- 11. The Treasurer is still finalizing reports for 2018. As soon as that is completed all records will then go to Jerome Bignoli for the annual report to be completed for the state and then to Mondorf & Fenwick for the mandated state audit.
- 12. Motion by Member Anderson, second by Member Bush to appoint Oliver Blaise III of Coughlin & Gerhart and Mark Butler of The Law Offices of Mark C. Butler, PLLC as our attorney for 2019. Member Bush will reach out to Mark Butler from The Law Offices of Mark C. Butler, PLLC to see if he would work with the District for the year 2019. All aye; motion carried.

NYSEG was called back to turn on the power to the Station. The cost for the new breaker with installation would be roughly around \$2,985.00. Motion by Member Bush, second by Member Anderson to purchase the new breaker and surplus the old generator. All aye; motion carried.
- 20. Motion by Member Bush, second by Member Anderson to have the map of the district lines framed and hung on the wall in the Board Room. Rob Brady will take care of getting the map framed. All aye; motion carried.
