ENDWELL FIRE DISTRICT BOARD OF FIRE COMMISSIONERS MEETING October 20, 2021

Meeting was called to order at 4:00 pm by Commissioner Anderson.

PUBLIC HEARING ON THE BUDGET: This is the public hearing regarding the 2022 proposed budget. In accordance with New York State Town Law; all Fire Districts must, prior to the adoption of their budget, hold a public hearing on their budget. This budget hearing must be held in such a manner to maximize participation in the budget process. The purpose of this hearing is to discuss the contents of the budget. The Board of Fire Commissioners in accordance with legal requirements has adopted their proposed budget on September 15, 2021, which is 21 days prior to this budget hearing.

Since the Endwell Fire District maintains a website, the proposed budget was posted on that website pursuant to the requirement of the Town Law.

The notice of public hearing specified the time and date when and the place where this public hearing would be held.

Upon its adoption, the Endwell Fire District secretary also made available for inspection, and copying of the proposed budget to any interested person during district office hours.

The purpose of this public hearing is to allow member of the public to make comments on the budget. Any person may be heard in favor of, or against, the preliminary budget or any item in it. Please note that this is only a proposed budget until the Board of Fire Commissioners adopts the final budget.

This budget must be adopted no later than November 4, and submitted to the town budget officer by November 7.

The 2022 proposed budget was presented.

The public comments period began. Chairman Anderson asked if any person present wished to be heard on the proposed budget may come forward so that that person may be heard in favor of, or against, the proposed budget or any item in it.

There were no comments therefore the public hearing regarding the 2022 proposed budget was closed at 4:05 pm.

Motion by Commissioner Battaglini, second by Commissioner Storm to approve the minutes of the September 15, 2021 meeting, and the special meetings held on October 01 and October 07, 2021. All aye; motion carried.

TREASURER'S REPORT: Motion by Commissioner Battaglini, second by Commissioner Storm to accept the Treasurer's Report and Capital Reserve Summary. All aye; motion carried.

- 1. 100th Anniversary Updates: No updates.
- 2. Station 3: The Station 3 Facility Condition Assessment proposal due was changed to November 16, 2021 from October 15, 2021 to give companies a little more time to put a proposal together.
- 3. Station 1 Apparatus Floor: Delta Engineers conducted the bid opening at their office on October 20, 2021 at 10:00 am. Only one completed bid was received from Marchuska Brother's Construction, LLC in the amount of \$299,000.00. Motion by Commissioner Del Bianco, second by Commissioner Battaglini to reject the bid as this was above the planned funding for the project and hold off until the spring of 2022. All aye; motion carried.
- 4. Purchasing of New Apparatus: Motion by Commissioner Storm, second by Commissioner Hamzik to cover the travel expenses for 5 people in the amount of \$4,000.00 for the prebuild meeting in Dublin, Ohio. All aye; motion carried.
- 5. Utility 31-11 (2007 Ford Van): Motion by Commissioner Storm, second by Commissioner Hamzik to accept the bid in the amount of \$10,800.00. All aye; motion carried.
- 6. Basement Storage Rooms Repairs: Commissioner Hamzik stated that the rooms have been clean out so that Southern Tier Basement can begin their work. Waiting on Southern Tier Basement to response back with when the work could begin.

Correspondence(s): New York State Volunteer Firefighter Cancer Benefit Program Updates

Thank you for your membership in the New York State Volunteer Firefighter Cancer Benefit Program. FASNY, NYSAFC and AFCSNY partnered with The Hartford to create a program that offers eligible volunteer firefighters cancer protection as required by GML 205-CC effective January 1, 2019. The coverage will automatically renew on January 1, 2022.

The Program offers two different cancer coverages. The basic program covers **the specific cancers listed in GML 205-CC**. The enhanced program covers more types of cancer **including lung cancer**.

IMPORTANT CHANGES Effective January 1, 2022:

A. 15% Rate Decrease

1. For 2022, the cost of the Basic Program will be \$132.60 per firefighter per year

- 2. For 2022, the cost of the Enhanced (all cancers) Program will be \$169.15 per firefighter per year
- B. Contract Change Regarding Eligibility for Coverage:

The definition of **Eligible Volunteer Firefighter** has been amended to allow for easier determination of eligibility per OFPC guidance:

A volunteer interior firefighter who has five or more years of faithful and actual service in the protection of life and property from fire subsequent to having successfully passed a physical examination which failed to reveal any evidence of Cancer; and,

has submitted or is able to submit proof of five years of interior firefighting service by providing verification that he/she has passed at least five yearly certified mask fitting tests as set forth in 29 CFR 1910.134 or the applicable National Fire Protection Association Standards for Mask Fit testing; or, for firefighters who entered fire service prior to January first, 2020, documentation identified by the office of fire prevention and control in rules and regulations promulgated pursuant to subdivision seven of this section which shall include, but not be limited to, training or certification records, health care provider records, internal fire department records, or any combination of official documents capable of evidencing that the firefighter meets the aforementioned requirements

C. Contract Change Allowing Optional Coverage for Exterior Firefighters:

The definition of **Eligible Volunteer Firefighter** has been broadened to include exterior firefighters that meet the definition below. You can now include exterior firefighters on your census, should you wish to purchase this benefit on their behalf. GML 205-CC <u>does not</u> mandate the purchase of this benefit for exterior firefighters.

Eligibility Description: A volunteer exterior firefighter who has five or more years of faithful and actual service in the protection of life and property from fire subsequent to having successfully passed a physical examination which failed to reveal any evidence of Cancer.

Motion by Commissioner Battaglini, second by Commissioner Hamzik to adjourn the meeting at 4:15 pm. All aye; motion carried.
