The Public Hearing on the 2024 Budget was called to order at 6:30 p.m. by Commissioner Anderson.

PUBLIC HEARING ON THE BUDGET: This is the public hearing regarding the 2024 proposed budget. In accordance with New York State Town Law, all Fire Districts must, prior to the adoption of their budget, hold a public hearing on their budget. This budget hearing must be held in such a manner to maximize participation in the budget process. The purpose of this hearing is to discuss the contents of the budget. The Board of Fire Commissioners, in accordance with legal requirements, has adopted their proposed budget on September 27, 2023, which is 21 days prior to this budget hearing.

Since the Endwell Fire District maintains a website, the proposed budget was posted on that website pursuant to the requirement of the Town Law.

The notice of the public hearing specified the time and date when and the place where this public hearing would be held.

Upon its adoption, the Endwell Fire District secretary also made the proposed budget available for inspection and copied it to any interested person during district office hours.

The purpose of this public hearing is to allow members of the public to make comments on the budget. Any person may be heard in favor of or against the preliminary budget or any item in it. Please note that this is only a proposed budget until the Board of Fire Commissioners adopts the final budget.

Prior to the public comment portion of this budget hearing, we will hear from the Fire District Treasurer, who will make a brief presentation about the preliminary budget to the Board of Fire Commissioners and members of the public who are present. The Fire District Treasurer will be asked to submit the proposed budget to the Board of Fire Commissioners and members of the public who are here.

This budget must be adopted no later than November 4 and submitted to the town budget officer by November 7.

The 2024 proposed budget was presented.

Commissioner Anderson stated the public comments period began. Chairman Anderson asked if any person present wished to be heard on the proposed budget and that person may come forward so that that person may be heard in favor of or against the proposed budget or any item in it. Chairman Anderson requested that if anyone wishes to address the board on the proposed budget, to please stand up and clearly state their name and address for the record. Comments are to be limited to five (5) minutes. All questions are to be directed to the board or the treasurer. He reminded the public that this was not a question-and-answer session and that questions would be answered at the conclusion of the public comments period.

There were no comments from the public.

Commissioner Anderson states the public comments period of this annual budget hearing has now concluded. The Board of Fire Commissioners members are now allowed to ask questions.

No Board of Fire Commissioners members had questions regarding the 2024 proposed budget.

Commissioner Anderson stated that this public hearing regarding the 2024 proposed budget had been declared closed. Motion by Commissioner Storm, second by Commissioner Hamzik, to close the public hearing and the budget adoption will be made in the monthly board meeting proceeding this hearing. The public Hearing was closed at 6:45 pm.

Commissioner Anderson called the Board of Fire Commissioner's monthly meeting to order at 7:00 p.m.

Motion by Commissioner Battaglini, second by Commissioner Hamzik, to approve the September 27, 2023 meeting. All aye; motion carried.

TREASURER'S REPORT: Motion by Commissioner Battaglini, second by Commissioner Storm, to approve the treasurer's report and the capital reserve summary. All aye; motion carried.

Unfinished Business:

- 1. Station 3: Keegan Coughlin with COUGHLIN & GERHART will create a letter to LaBella Associates and create the Request for Proposal for an engineering and designing firm.
- 2. Bunk-In Program: Kevin Mahoney reviewed the RFP and made some revisions. Erika will update the RFP and send it to the Board of Fire Commissioner. Dates will need to be discussed for the RFP.
- 3. New Apparatus 2024 Chevrolet Silverado: Waiting for the cab and chassis. Chief Michael Battaglini ordered the service body. Chief Michael Battaglini has been in contact with Bush Electronics to work on a lighting package for the new Utility 31-1.
- 4. New Apparatus Engine: The new engine was ordered, and the prebuild meeting with Sutphen was completed. There is a two-year turnaround time for the truck to be built and delivered.
- 5. Updates to Board Room: The Johnsonite Traditional Wall Base 48 Grey WG and the flooring is Mannington Commercial Collection: Spacia Style: Wood Color: Nordic Oak (SS5W2550) was

chosen. Send the choices to Rug Fair Commercial & Industrial for an estimate.

We need to purchase 10 of the Duty-Built High-Back Swivel Office Chairs with loop arms in the amount of \$3,325.00.

Jeff's Painting will complete the painting of the board room for the price of \$1,650.00.

Hammer's Woodworking is working on the custom boardroom table with the District and Fire Department logos.

- 6. Gear Lockers: The gear lockers were ordered and should be installed in December. The outlets behind the current lockers need to be moved so the new lockers can be installed flushed to the walls. T&B Electric will complete the task for us.
- 7. Fire District Rules & Regulations: No action at this time.
- 8. New Tower Dedication Plaque: Plaque was ordered from Endicott Artistic Memorial Company. Waiting for the plaque to be delivered.
- 9. PA System: AV Sound in Owego submitted price quotes for updating the PA system at Station 1.

The top portion (Option A) is AV Sound's recommendation for upgrading and overhauling the system, replacing the old electronics, and upgrading the speakers in the bay and locker area—price - \$5,895.45.

Below (Option B) is for basic repair/ tracing out and repairing the existing equipment without upgrading—price - \$1,287.80.

Motion by Commissioner Hamzik, second by Commissioner Lewis, to have AV Sound complete Option A not exceeding \$6,500.00 and to send a 50% down payment of \$2,900.00 to schedule the work. All aye; motion carried.

10. 2024 Budget: Motion by Commissioner Battaglini, second by Commissioner Hamzik, to approve the proposed 2024 budget of \$1,388,702.00 with \$1,353,820.00 to be raised by taxes. All aye; motion carried.

- 14. Appoint Election Board and Compensation: Motion by Commissioner Storm, second by Member Battaglini, to appoint Davey Cortes as election chairperson and Amy Cortes and Christopher Lee as election tellers. Each will be paid \$70 for their time—all aye; motion carried.
- 15. Inspection Dinner & Gift Ideas: Commissioner Storm and Fire District Secretary Erika Pereira will look into gift ideas. The Inspection Dinner will be held on Saturday, March 23, 2024, at 6:00 pm at the Riverdale Banquet Hall.
- 16. Application for Volunteer Firefighters / Ambulance Workers Exemption: The enactment of the new Real Property Tax Law §466-a, making the partial real property tax exemption for volunteer firefighters available throughout the state with local government approval, requires a public hearing and an adopted resolution. A Board of Fire Commissioners in a fire district wishing to confer this benefit on its volunteer firefighters would need first to hold a public hearing. At that time, the Board would take public comments on the proposed action before considering the adoption of a resolution that would provide the partial real property exemption.

A sample public hearing notice and resolution to grant the exemption was handed out for review.

Once approved, we must file the exemption application in the assessor's office on or before the appropriate taxable status date, which, in most towns, is March 1. Commissioner Hamzik & Commissioner Storm are consulting with our assessor for more information and to confirm the deadline for our municipality.

Motion by Commissioner Storm, second by Commissioner, to hold a public hearing on the Volunteer Firefighter Real Property Tax Exemption pursuant to real property tax law §466-A on December 20, 2023, at 6:00 pm. All aye; motion carried.
