RESOLUTION DECLARING A CERTAIN FIREFIGHTING VEHICLE, SPECIFICALLY A 2012 CHEVROLET TAHOE (FOUR WHEEL DRIVE, FOUR DOOR SUV), AS SURPLUS, AND AUTHORIZING THE BOARD OF FIRE COMMISSIONERS TO SELL THE FOREGOING VEHICLE TO THE WRIGHT TOWNSHIP VOLUNTEER FIREMANS ASSOCIATION FOR \$35,565.99, SUBJECT TO PERMISSIVE REFERENDUM.

RESOLVED, this 15th day of February, 2018, by the Board of Fire Commissioners of the Endwell Fire District of the Town of Union, County of Broome, State of New York, as follows:

- Due to the financial consideration of a certain vehicle owned by the Fire District, and to maintain the readiness and effectiveness of its vehicle fleet for the public benefit, and to provide its volunteer firefighters and emergency responders with the latest and safest equipment to use in the hazardous duty they perform in service to the community, and to avoid expenditures on vehicles whose useful service life is limited, the Board of Fire Commissioners has determined that the vehicle described below in Section 2 is surplus and no longer needed for firefighting purposes.
- Section 2. The vehicle subject to this resolution is a 2012 Chevrolet Tahoe (four wheel drive, four door SUV), the value of which is estimated to be between \$20,000 and \$100,000.
- Section 3. The sale of the vehicle is hereby authorized to the Wright Township Volunteer Firemans Association, for the amount of \$35,565.99.
- Section 4. The Fire District treasurer is hereby authorized to execute all documents required to effectuate this transaction.
- Section 5. This resolution shall, before being effective, be subject to permissive referendum.
- Section 6. Notice of the resolution shall be published in the official newspaper of the Fire District, and elsewhere, by the Fire District secretary pursuant to the laws governing permissive referendums and special elections.
